A disciplined approach is implemented to select fundamentally strong American growth-oriented equities based on quantitative scores and relative strength.

1ST | Universe

Investor's Business Daily's (IBD) IBD 50 list which consists of 50 leading growth stocks showing strong relative price strength and top-notch fundamentals. Also used is the IBD New America list, which consists of companies with innovative products.

2ND | Rank

Identify potential candidates by IBD's composite rating which scores strength of fundamentals and technical factors.

3RD | Measure

Rate the potential candidate's performance over the last 52 weeks with IBD's relative strength.

4TH | Screen

Utilize Revelation Investment Research to analyze downside risk based on valuation, growth, fundamentals, and sentiment.

5TH | Decision

Select 33 stocks based on their scores, fundamentals, and technical analysis. Positions are reviewed regularly.

Description: The IntelliBuild Growth Composite invests in approximately 33 stocks of high-quality rapidly growing U.S. companies. The investment objective of the composite is capital appreciation. The IntelliBuild Growth Composite consists of fully discretionary portfolios, including those accounts no longer with the firm. For comparison purposes the composite is measured against the Standard & Poor's 500 Index (S&P 500). The Composite inception date is October 1, 2013.

Performance presented are time-weighted returns. Valuations and performance is reported in U.S. dollars. Composite performance is presented on gross-of-fees and net-of-fees basis and includes the reinvestment of income (dividends/interest). Gross-of-fees returns are presented before management and custodial fees but after all trading expenses. Net-of-fees returns are calculated by deducting a model management fee of 0.3125, ¼ of the highest annual management fee of 1.25%, from the quarterly gross composite return. Actual advisory fees incurred by clients may vary.

The benchmark is the S&P 500, a market value weighted index comprised of 500 of the largest publicly traded U.S. companies. An index should only be compared with a mandate that has a similar investment objective.
